They may work in one of the OCC's field offices located across the U.S., at banks, or at bank branches.

The Office of the Comptroller of the Currency (OCC) charters, regulates, and supervises all national banks and federal savings associations (collectively, banks), as well as federal branches and agencies of foreign banks. In regulating banks, the OCC has the power to:

- * examine the banks.
- * approve or deny applications for new charters, branches, capital, or other changes in corporate or banking structure.
- * take supervisory actions against banks that do not comply with laws and regulations or that otherwise engage in unsafe or unsound practices.

The OCC also can remove officers and directors, negotiate agreements to change banking practices, and issue cease-and-desist (C&D) orders as well as civil money penalties (CMP).

- * issue rules and regulations, legal interpretations, and corporate decisions governing investments, lending, and other activities.

Boards of directors play critical roles in the successful operation of banks. The OCC recognizes the challenges facing bank directors.
